

## **Clear Brook Aquatics Booster Club Meeting Minutes November 1, 2005**

**Meeting Called to Order** Lee Fabling called the meeting to order at 6:00 p.m.

**Treasurer's Report** Last month CBABC balance was \$8, 867.00.  
Current balance is \$6,900  
The total spent on the Water Polo banquet was \$282.  
Our most recent expenses were flowers for seniors,  
decorations for the banquet, swim caps, water polo caps.

### **Water Polo**

#### **Discussion**

- Lee Fabling discussed using Earl Stokes Photography for water polo and swimming pictures (team, individuals, and seniors). She asked for tentative dates when to have the team come for pictures.
- Names for varsity board are ready.
- Coach Schurdell mentioned that during swim season there will not be practice the day after a travel meet.

#### **Action**

- Coach Schurdell would recommend that this year the pictures be done at the end of swim season. However, for next year he would like water polo pictures during water polo season and swimming pictures during swimming season since it is easier to gather all the athletes.
- Varsity board will be finished the first week in November.

### **Swimming**

#### **Discussion**

- Jingle Bells is the weekend of December 9 and 10. It will be the same format as last year but a much larger meet. Diving will be done Friday and swimming events will be on Saturday, probably from 9-3. We will need hospitality for both days and concessions just for Saturday. - Becky Au presented a design for the Jingle Bells t-shirts. There is an option of another design on the back and three different colors.
- Brook will not be attending the Lamar Invitational. The first swim meet will be November 10.
- The team is in need of a new computer to be able to run the meets. Coach Schurdell had to borrow a computer to run the Intra-Squad meet. He also discussed the type of computer needed.

#### **Action**

- Sign-in sheet distributed for volunteers to help with the ribbons and the meet. We will meet at Lisa Ruchte's house on Monday, November 7 at 6:30 p.m. to work on the ribbons.

- Sign-in sheet for volunteers for the first meet was distributed.
- Becky Au will have the athletes vote for the color of the Jingle Bells t-shirt and also the design on the back of the shirt.
- The Booster Club will try to purchase a computer the weekend of November 5/6 to run the meets.
